- When a student registers for a class division, they are required to take all ballet/modern classes in that division, or comparable, when authorized by the Director. Individuals wishing to attend Upper Level (Intermediate – Advanced) Jazz and Modern Classes that are not registered in that division, will only be allowed with the Director/Faculty's permission.
- Tuition payments are payable in full at the time of registration with a \$25.00 Non-Refundable Yearly Registration Fee for NEW STUDENTS registering for the Summer Intensive. Students are registering for the entire Summer Studies (5 weeks) and are liable for the entire fee, unless they are unable to attend due to injury or health reasons, at which point a doctor's diagnosis and letter must be submitted to the School/Director for non-liability of the full tuition due. There are no refunds, pro-rating or credits applied once the Summer Studies has begun. Make-up Classes may be done with approval in other class levels. There is a \$30.00 fee for any returned checks.
- IF YOU ARE UNABLE TO REGISTER FOR THE ENTIRE PROGRAM, PAYMENT BY THE CLASS (\$20.00 PER CLASS) IS REQUIRED. PRO-RATED RATES FOR MISSED WEEKS IS NO LONGER APPLICABLE. Make-up Classes may be done with approval in other class levels.
- In order to reserve your child's placement in Summer Studies or Dance Camp to confirm the class will take place, this Registration Form and a \$25.00 non-refundable deposit (APPLICABLE TO TOTAL AMOUNT DUE) is due for all students. An additional \$25.00 Non-Refundable Yearly Registration Fee is due for NEW STUDENTS ONLY. Payment to be paid to the office – BY – JUNE 23RD
